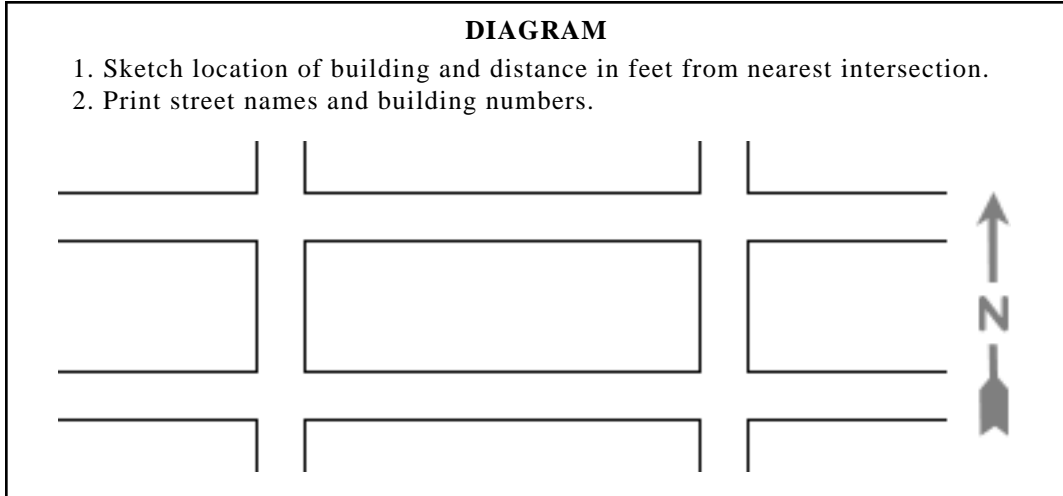

**GENERAL PERMIT ISSUED UPON ACCEPTANCE OF THIS APPLICATION WILL BE SUBJECT TO THE FOLLOWING CONDITIONS**

1. The installer shall abide by all provisions of the ordinances, rules and regulations of the Oyster Bay Sewer District.
2. This permit shall not relieve the permittee or installer from obtaining any additional permits required by law, ordinance or regulation of New York State, Nassau County, Town of Oyster Bay.
3. The permittee shall maintain the building sewer up to the street sewer.
4. The installers shall not cover the installation before inspection is made by a representative of the Oyster Bay Sewer District.
5. The permit must be kept on the premises, available for exhibition at all times during the construction of the work and it shall become void unless connection is made within thirty (30) days from the date of issuance. No refund will be made for permit issued and not used within the time limit given.
6. The permittee shall notify the Oyster Bay Sewer District immediately in the event of any accident, change of conditions or other occurrence that occasions discharge to the street sewers. Failure to comply with this condition shall void this permit.
7. Cesspools, septic tanks or overflow pools are not allowed to be pumped, drained or discharged into the street sewers.
8. The Oyster Bay Sewer District makes no warranty of the location of the spur house connection and the location of same shall be the sole responsibility of the permittee.

The owner or lessee (permittee) and the licensed plumber or approved contractor (installer) have read the conditions on page 2 of this document and all the rules and regulations of the Oyster Bay Sewer District completely and thoroughly. These conditions will govern the installation and operations of the sanitary sewer by the permittee and appear on the face of the permit when issued. The permittee and the licensed plumber or approved contractor will be held legally responsible for the adherence to all of these conditions, and all ordinances, rules and regulations of the Oyster Bay Sewer District.
